Message from Mr. Sundararaman, T No : 19th Batch Alumnus of MIT Dear Dr. Elamvazhudhi,

I am flattered by your request that I could share my memories in the emagazine.

When I see a lot of successful entrepreneurs amongst the alumni's , my memories does not add up to their unsung contributions. I was the project manager for a prestigious defense project for DRDL at Hyderabad involving putting up a liquid rocket engine test stand having highly advanced instrumentation and control involving ultra high speed UV recorders running at a chart speed of 10 meters per second. This project (code name Valiant was even mentioned by Dr. Abdul Kalam in his book "The Wings of Fire" although my name was not mentioned).



Once it was handed over, I had to settle down to a very common and garden instrument engineering assignment again at EIL.

The positive side was that the company from Holland who supplied an ultra-pure Nitrogen plant asked me if I could join them in Holland which I accepted in 1976.

My work in Holland involved a lot of international assignments worldwide in countries such as Yugoslavia, Egypt, Spain, France, Germany, Malaysia, Poland, Hungary, India, UK, Italy etc etc.

Thanks to my wife (she took care of the family whilst I was away for long period assignments), I was able to make a career in that company where I finally ended as a Sales/ Proposal manager and in total had worked for 38 years in the outfit.

I envy a lot of alumni entrepreneurs because I concentrated more on my work than starting anything of my own. Thus may be due to comfortable living in a liberal country like Holland and had no challenges. The entrepreneurial spirit will come only when one has challenges supported by some financial support. I had nine of these.

After my retirement in 2015, I decided to spend more time in golfing and tennis to keep physically fit as the company pension coupled with the generous Dutch state pension made me even more comfortable which prevented me from taking up any new challenges.

This story is not suited for upcoming youngsters as they might be tempted to seek comfort zones unlike the numerous entrepreneurs of MIT alumni's. I have a contented happy life (less after materialistic aspect) and enjoy additionally Indian classical music.

My story is a very common variety which will not inspire for persons with ambitions. This is a personal note to you as to why I don't want to publish any memoirs.

I don't mind guiding students such as the one you organized last year but does not seek any glory.



MITians Studying in Abroad...

I am Thayanithi Ayyachi and I have completed my bachelor's degree in Rubber in Plastics Technology (August 2011 – May 2015) from MIT Campus of Anna University. I am currently pursuing a Master's degree in Macromolecular Materials at KTH Royal Institute of Technology (August 2019- June 2021).

Just like for many others, MIT opened my eyes and showed me the whole world of opportunities. Thanks to the strong care of faculty towards students (especially in the Department of Rubber and Plastics Technology), di-



rect and indirect guidance from alumni, the curriculum, and the peer-group, the extra-curricular and cocurricular activities, all of which contributed in opening up a new world to me, who hailed from a very modest background. Thanks to the FFE Scholarship which introduced me to exceptional mentors, who have great roles in molding me into what I am.

By the end of my bachelor's degree, I decided to support my family financially and appeared for on-campus placements. In July 2015, I began my professional career as a Graduate Engineer (R&D) in Harita Fehrer Limited, Hosur (a sister concern of TVS Motors Limited) where I was a part of the new Product Development team and developed various trim parts and processes, and performed failure analysis, DOE studies, polymer testing, etc. Later, in September 2016, I moved to **Indian Oil Corporation Limited, India's topmost Fortune 500 Company,** through the GATE 2016 exam (and also cleared group discussion/group task/personal interview round). There, I was working with various domains in the marketing of polymers in Gujarat (PP, LLDPE, HDPE), initially with zonal coordination, followed by technical services, and finally in sales in Tamilnadu.

Among other benefits that I obtained because of my industrial experience, it made me realize the challenges of developing medical products and their importance in patients' life. This made me choose the Master's programme in Macromolecular Materials at KTH Royal Institute of Technology (Sweden), which has courses related to chemistry as well as biomedical materials, besides the state-of-the-art research in biomaterials. Studying a master's in Macromolecular Materials at KTH further deepens my knowledge of different polymers such as biopolymers, fibres, degradable polymers, etc. KTH provides extraordinary facilities for my study and the opportunity to interact with students and professors from diverse academic/professional and cultural backgrounds. Moreover, I get a good laboratory experience by working in the research group of Prof. Anna Finne Wistrand.

I cannot express my gratitude in words to the KTH Scholarship which covers the tuition fees of my entire master's studies, without which I wouldn't have decided to study. Besides, I wish to express my sincere thanks to the **Tata Trust** and allied trusts for providing me with **J N Tata Fellowship** that covers my accommodation expenses and travel/visa charges. I wish to thank my parents and family members, friends, well-wishers, and mentors who continue to extend their support in achieving my goals.

Indeed, it was a tough decision to leave a highly paid, secure, coveted job in Indian Oil Corporation Limited. However, the experience of my study and research at KTH and living in Stockholm never allows me to ponder on that decision. As I always believe, the best is yet to come. I wish to be an academic researcher in the future and my next goal is to obtain a PhD position.


