

Highlights of Union Budget 2021–2022



General

- 1. First digital Budget in the history of India
- 2. Vehicle Scrapping Policy. Vehicle Fitness Test after 20 years in case of Personal vehicle and 15 years in case of commercial vehicles
- 3. 64,180 crores allocated for New Health Schemes
- 4. 35,000 crores allocated for Covid Vaccine
- 5. 7 Mega Textile Investment parks will be launched in 3 years
- 6. 5.54 lakh crore provided for Capital Expenditure
- 7. 1.18 lakh crore for Ministry of Roads
- 8. 1.10 lakh crore allocated to Railways
- 9. Proposal to amend Insurance Act. Proposal to increase FDI from 49% to 74 %.
- 10. Deposit Insurance cover (DICGC Act 1961 to be amended). Easy and time bound access of deposits to help depositors of stress banks.
- 11. Proposal to revive definition of 'Small Companies' under Companies Act 2013. Capital less than 2 Cr. and Turnover Less than 20 Cr.
- 12. Disinvestment: IPO of LIC, Announced Disinvestment of Companies will be completed in FY 2021-22

Direct and Indirect tax

- 1. Senior Citizens: Reduced Compliance burden. 75 years and above. Proposal not to file ITR if only pension income and interest income.
- 2. Reduction in time for IT Proceedings: Reopening of Assessments period reduced from 6 years to 3 years except in cases of serious tax evasion cases.
- 3. Proposal to constitute 'Dispute Resolution Committee'. (Taxable income 50 lakhs and disputed income 10 lakh).
- 4. National Faceless Income Tax Appellate Tribunal Centre
- 5. Relaxations to NRI: Propose to notify rules for removing hardship for double taxation.
- 6. Tax Audit Limit: Proposal of tax audit increased from 5 Cr. to 10 cr. (Only for 95% digitized payments business)
- 7. Propose to provide relief on advance tax liability on dividend income.
- 8. Propose to include tax holidays for Aircraft leasing companies.
- 9. Prefiling of returns (Salary, Tax payments, TDS etc.) Details of Capital gains from listed Securities, dividend income, etc. will be prefilled.
- 10. Small Charitable Trusts. Increased from 1 crore to 5 crores (Compliance limit).
- 11. Late deposit of employee's contribution by employer will not be allowed as deduction.
- 12. Incentive to startup: Tax holiday exemption for one more year
- 13. Duties reduced on various textile, chemicals and other products
- 14. Gold and Silver (BCD reduced)
- 15. Agriculture Products: Custom duty increased on cottons, silks, alcohol etc.




MIT Campus News...

Introduction

I am immensely happy for being given an opportunity to write about my experience of my admission into the University of Waterloo. I thank Dr. K Elamvazhuthi, my great senior for encouraging me to write this article. I am Yasmin Shabeer, a 2020 passed out student from the prestigious Madras Institute of Technology and a current master's student at the University of Waterloo, Ontario, Canada.

My hometown is Salem, Tamilnadu. I did my high school in Vellore and of course, my undergraduate in Chennai. I would like to elaborate on my source of inspiration that made me determined to come back to Canada. Yes, this is my second time in Canada.



Madras Institute of Technology

MIT does not need an introduction. It has always been a hub of talent producing factory. MIT inspires everyone in their own way. I remember back in school how strongly, I wanted to get into MIT. Thus, I consider the biggest achievement of my school days to be getting into MIT itself. I am pleased to say it all paid off in the end. I got into Rubber and Plastics Technology department. A unique course with abundant opportunities. I am always grateful to my teachers as they never stopped encouraging us to be innovative and creative as much as possible. My desire to study abroad was greatly influenced by an internship called MITACS. My journey towards UOW started from here. In the mid of my second year, I stumbled upon this fully-funded trip to Canada for doing a research internship.

MITACS

MITACS is a nonprofit national research organization in Canada. They provide a platform to pair students from all over the world to Canadian Universities/professors to do a three-month-long research internship in Canada. I put a lot of work into my MITACS application and was interviewed by two different professors. I was matched to a project in the first wave of selection. I did my MITACS Globalink research internship at the University of Montreal under the supervision of Dr. Fabio Cicoira. This was my first time in Canada (May 2019), in fact, the first time out of my country. From my experience, I found Canadian Universities to be the most welcoming places where students can learn, improve their skills and eventually contribute to the globe. Canada is known for its multi-cultural diversity and high standard of living. At the end of this internship, I was determined to come back.

University of Waterloo

When I returned home, I finished all the required examinations to apply to Canadian Universities. I started sending emails to all potential professors who had openings in their labs for master's students. I got matched to several Universities. But UOW has a great reputation throughout the world and stands first in so many respects. UOW is at the forefront of innovation and is home to transformational research and inspired learning. It is known for coop programs and the highest placements all over Canada.

My current projects are in collaboration with high-end industries thus I am hoping to give my best to get placed in such institutions at the end of my degree. The path towards UOW was highly competitive and challenging amidst Covid-19 and everything but I am glad I could make it with all the support from my parents and teachers. Studying abroad is expensive especially for someone who comes from a middle-class background. 
