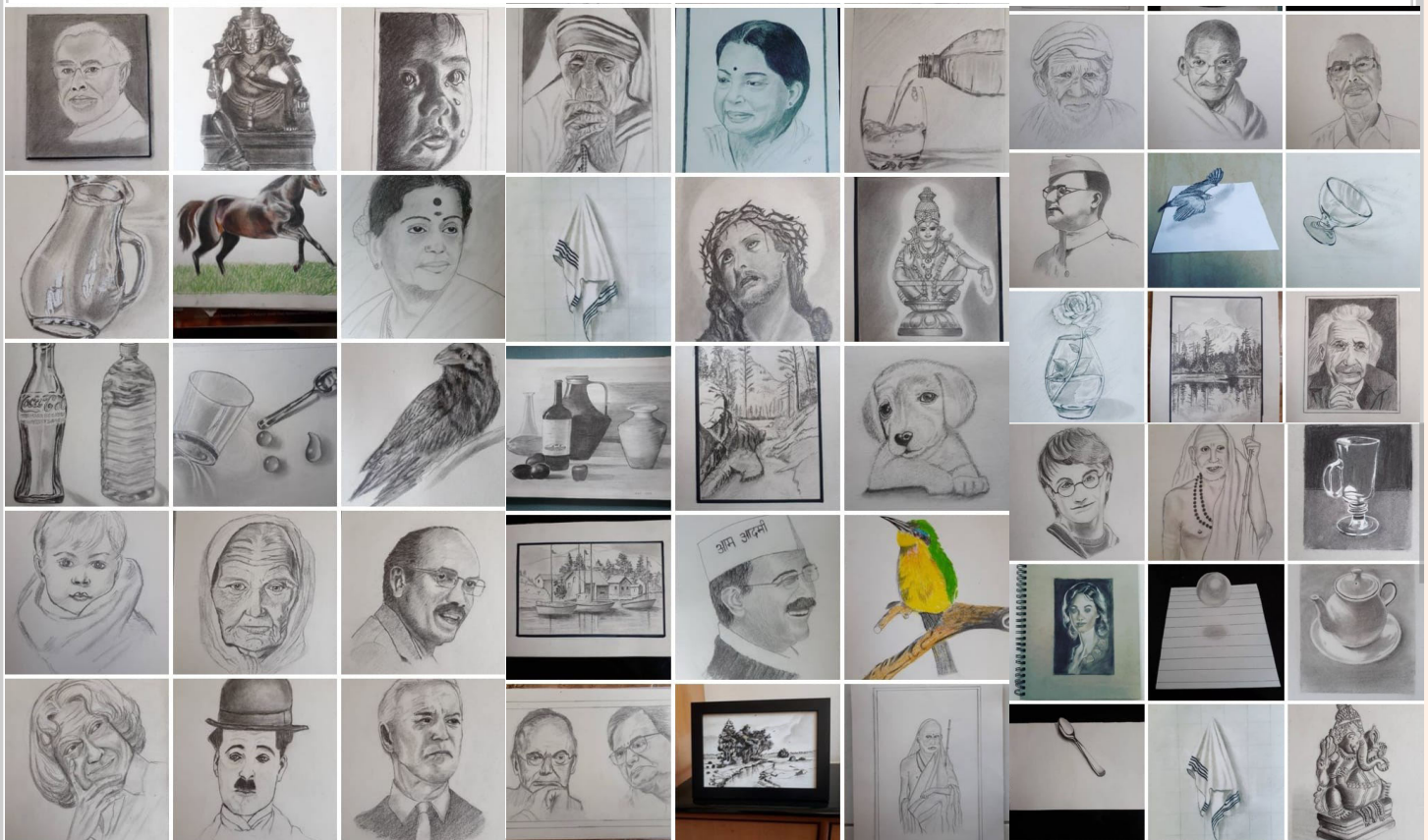

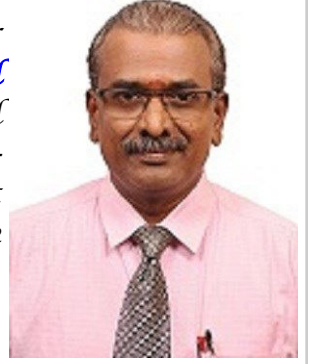

UGC to allow experts without PhD to teach in central univ

New Delhi: In a major move to rope in industry experts and professionals, the University Grants Commission (UGC) is doing away with the mandatory PhD requirement to teach in central universities. Special positions — professor of practice and associate professor of practice — are being created. This will allow, say a diplomat, to walk in to teach international relations.

“There are many experts who want to teach. There could be someone who has implemented large projects and has a lot of on-the-ground experience, or there could be a great dancer or a musician. But we can’t appoint them going by the present rules,” said UGC chairperson M Jagadesh Kumar.

Therefore, it was decided that special positions will be created, he said. “There would

be no need for a PhD, the experts will just need to have demonstrated experience in a given domain,” he added.

These positions can be either permanent or temporary depending on the institutions’ requirements. Experts who have superannuated at the age of 60 can also join as full or part-time faculty and work till the age of 65.

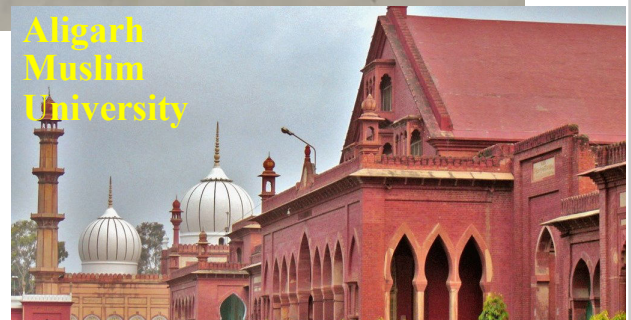
Vice chancellors of central universities in a meeting with Kumar on Thursday decided to set up a committee to work on the amendments in the regulations for teachers’ appointment. The meeting was called to discuss the pro-

gress in implementation of the National Education Policy among other things.

The UGC is also planning a centralised portal to track, streamline and ensure appointments of teachers without delay. According to the ministry of education, as of December 2021, there were over 10,000 teaching positions lying vacant in centrally funded institutions.

An industry professional with a job can join in a part-time position or give up his/her job to join as a full-time faculty. Experts who have superannuated at the age of 60 can also join as full or part-time till the age of 65.

Another decision taken at the meeting is work on a centralised faculty recruitment portal for the CUs so that prospective candidates can register and whenever a university announces those positions they will appear in the portal.

Startup signs MoU on rail safety tech

Bengaluru: The IISc-incubated startup L2MRail and Society for Innovation and Development (SID) at the institute have signed an MoU with the Dedicated Freight Corridor Corporation of India (DFCCIL) to enhance rail safety by automating rail wagon inspection and defect detection.

The L2MRail team and IISc have pioneered the Machine Vision-Based Inspection System (MVIS), the first of its kind in India, overcoming the limitations of human inspection. "While rail safety has traditionally been associated with passenger carriers, freight trains also require real-time monitoring. While accidents are always a possibility, goods also need to arrive on time, for which timely inspection is essential. We are proud to say that the home-grown L2MRail is stepping in to fill in that gap," said Prof Gurumorthy, chief executive of SID.

MVIS can enable automated inspection of wagons during day and night, at high train speeds, with wide variations in load and wagon types and on any kind of terrain.

This end-to-end automated system will be developed within a year and can be deployed anywhere in the world for fast detection of defects in wagons.

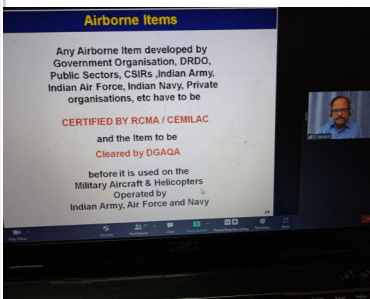
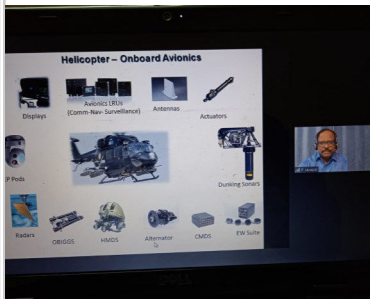
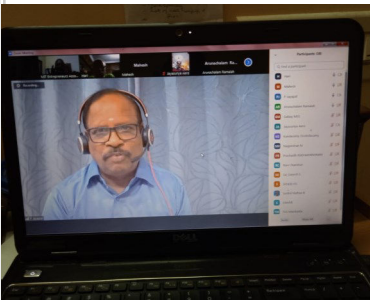
Initially at a single location, MVIS will eventually be installed across the stretch of eastern and western corridors between Kolkata and Ludhiana (eastern) and Mumbai and Dadri (western). "While trains are routinely inspected, manual inspection has its limits. We welcome the channeling of innovative solutions towards strengthening rail safety through predictive maintenance, preventing potential accidents and downtime," said RK Jain, MD of DFCCIL.

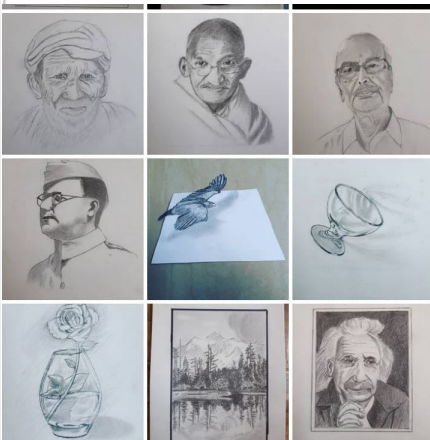
J. Padmanabhan T Number: 2154

Mr. J. Padmanabhan, known to more people as just JP, belongs to 21st batch Electronics. He was born in 1948, in Trivandrum, in a well educate family. His father was the Chief Engineer of Kerala PWD.

During his school days itself he had keen interest in science. With the help of magazines meant of hobbyists he assembled small electronic gadgets and installed them across the house. One neighbor, who was a scientist in ISRO, had a great influence in nurturing this interest and he facilitated reading many hours talking with him on space physics, space programs etc. A visit along with this scientist to Tumba Equatorial Rocket Launching Station (TERLS), ISRO, Trivandrum created a strong determination to build his career in the field of science and technology.

Padmanabhan did his BSc in Physics, Chemistry and Mathematics from Kerala University. During his BSc days every year he won first prize for Science Essay Competition conducted by the Department of Physics. After completing BSc, Padmanabhan joined MIT in 1969 in the department of Electronics. During his final year in MIT, he built a hard wired computer (It was the period before microprocessors came into existence) and exhibited it in an inter-collegiate competition held at Chennai, representing MIT. His exhibit was awarded second prize and later he was invited by the Central Ministry of Education for participation in a national level science exhibition at Delhi, which was attended by dignitaries like Prime Minister Indira Gandhi, ministers of Education, science and technology etc.

After the final year examinations, Padmanabhan did his project at VSSC, ISRO Trivandrum, developing a PCM System which gave him hands on experience in advanced design technologies and opened up the doors to secure his first job in ISRO itself. After completing DMIT, he joined Space Application Centre (SAC), ISRO, Ahmedabad as one of its early employees. During that time, SAC did not have a campus of its own. The design and testing labs were located in various residential apartment complexes. In the kitchen of one such residential flat, Padmanabhan did the design, assembly and tastings of his first system in SAC.

Padmanabhan worked in the Remote Sensing Division of SAC and developed systems for handling the satellite data received from early Remote Sensing Satellites of India. Being a bachelor at that time, he spent all his time in his lab and library. He strongly feels there is a wide gap between what one learns in the college and what one needs to know to handle the kind of designs being used in organizations like ISRO.

Being the first engineer of the newly formed division, he had the opportunity to build the division by adding infrastructure one by one, interact with senior scientists of various other divisions etc. Padmanabhan was sent to space research organizations of Hungary and France, to learn and bring advanced technologies to SAC. During his tenure in SAC, Ahmedabad, Padmanabhan presented many technical papers on his developments in various conferences.

During the eighties, private sector companies in India started entering high technology fields and many companies were looking for people with relevant experience. Because of his experience in both design of systems using advanced technologies as well as in setting up development facilities from the scratch, Padmanabhan had a number of offers to join the private companies. He joined one company in Cochin, which wanted to diversify from the present Electro Mechanical product line to manufacture of computer peripherals. He developed the R&D facility and later the production facility for this company.

After serving eight years in this position at Cochin, Padmanabhan joined Advanced Micronic Devices Ltd in Bangalore as head of R&D. His R&D developed single different types of computers, Real Time Systems, add on cards for various industrial applications etc. which were well accepted by the industry, aerospace and defence labs.

In few years a larger manufacturing facility became necessary for producing the developed products. Padmanabhan took up the responsibility of setting up a manufacturing facility and QC to meet the defence standards, established customer support, supply chain etc.

During the nineties Indian economy was liberalized and unrestricted import of all types of computers was permitted. That made local development of computers irrelevant and posed great challenge of survival for the highly skilled development team built over the years. To meet this challenge, Padmanabhan restructured the R&D to offer design services and take up development of custom projects for various defense and aerospace labs. This required ad-

vance technology products and technology for which he established business partnership with number of technology companies in USA, UK, Norway, Israel, etc. With the combination of latest technology products from principals and years of design and development experience, his team could develop systems which were used in prestigious projects of national importance like LCA (Currently Tejus), ALH, Prathvi missiles, Pilotless Target Aircrafts, Pilotless Surveillance vehicles, Submarine detection systems, Vehicle Tracking Systems, etc.

Over the years as his career grew, Padmanabhan became head of various divisions of the organization like Development, Technical Support, Sales, Marketing, independent finance and HR Training for his technology vertical. He grew along with the organization and retired as the President of the company in 2013.

Mr. Padmanabhan has been the project guide for many BTech and MTech students. He has presented many papers on various technical topics. He has been the visiting faculty in VIT, University of Cochin and had contributed in upgrading the syllabus of many Autonomous Universities. He has given number of talks at DRDO facilities to introduce latest technology which are relevant to their applications.

POST RETIREMENT

Mr. Padmanabha has a wide range of interests in areas like Carnatic Music, English Novels, Wild Life, Hindu Philosophy, Art and Science, long distance driving etc. After retirement he is busy with the pursuit of all these passions. He is a self-groomed artist regularly doing pencil sketches and charcoal sketches. His sketches are available on Instagram.

His articles on Advaita Philosophy and Bhagavad Gita are regularly being published in the Spiritual and Philosophy magazine “Tattvaloka” coming from Sringeri Mutt. JRD Tata flew the first flight of
Tata Airlines on October 15, 1932. The
airlines came to be known as Air India
following its nationalisation post Inde-
pendence.

Life came full circle for Maharaja on
Thursday, January 27, 2022 as India's
commercial carrier Air India returned to
the Tata Group on the day. The govern-
ment officially handed over the national
carrier to the business conglomerate after
the PM met Tata group Chairperson
Mr. Chandrasekaran.

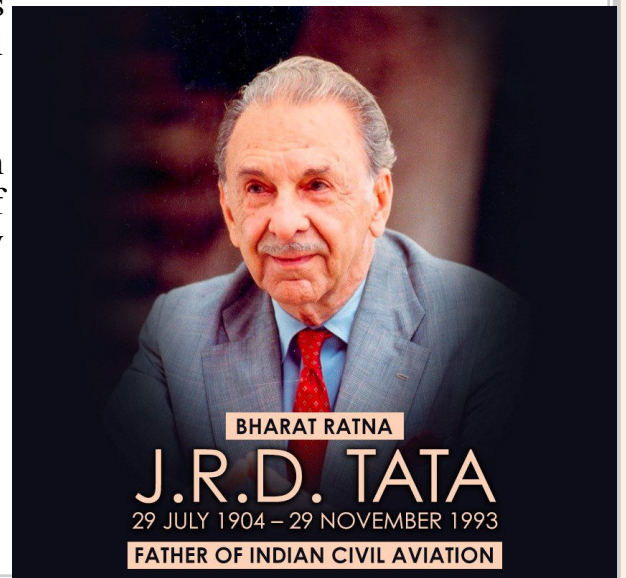
Air India was established 90 years ago in
1932 under the leadership of Jehangir
Ratanji Dadabhoi Tata, fondly known as
JRD Tata, the first Chairman of Tata
Group. During its initial years, Air India
was called as Tata Airlines. Later it was
nationalised and renamed as Air India.

JRD Tata who himself was an aviator and
the first civil aviation pilot of India, kept
the company close to his heart.

This followed when his successor Ratan
Tata took over the operations of the
group.

The first Flight: JRD Tata flew the first flight of Tata Airlines on 15th October, 1932. The first carrier flew on Karachi - Ahmedabad - Bombay route on a de Havilland Puss Moth aircraft that JRD himself operated. In the first year itself, after flying for around 2,60,000 kms, the company gained around Rs 60,000/-. Years later Tata Group set up Air India International along with the Government.

The iconic Maharaja came in the year 1938, when Bobby Kooka, who was one of the first employees of Tata Airlines, designed the logo of the company giving the carrier its identity for decades to come.

HOW TO PICK YOUR STOCK - PART 4

In this article we will study about Support and Resistance in Technical Analysis.

There are hundreds of thousands of market participants buying and selling stocks for a wide variety of reasons. Chart patterns put all buying and selling into perspective by consolidating supply and demand into a concise picture. As a complete pictorial record of all trading, chart patterns provide a framework to analyze the battle raging between bulls and bears. More importantly, chart patterns and technical analysis can help determine who is winning the battle, allowing traders and investors to position themselves accordingly.

While discussing candlestick patterns there is a point of entry where you enter the trade and the Stoploss point where the trade goes against you and you exit and Target where you book profits and exit trade,. We will discuss the same in this chapter.

The best way to identify the target price is to identify the support and resistance points. The **support and resistance (S&R)** are specific price points on a chart expected to attract the maximum amount of either buying or selling. The support price is a price at which one can expect more buyers than sellers. Likewise, the resistance price is a price at which one can expect more sellers than buyers.

THE RESISTANCE

As the name suggests, resistance is something which stops the price from rising further. The resistance level is a price point on the chart where traders expect maximum supply (in terms of selling) for the stock/index. The resistance level is always above the current market price.



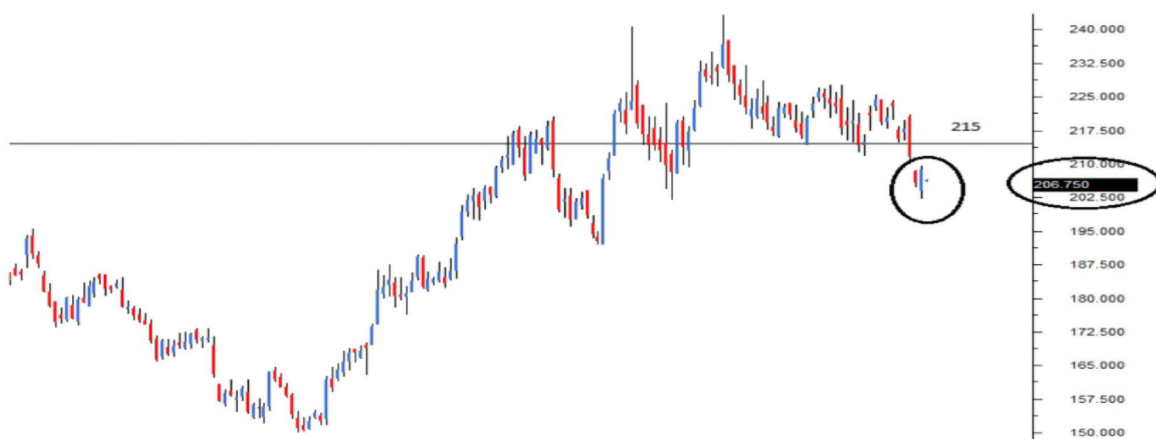

The likelihood of the price rising to the resistance level, consolidating, absorbing all the supply, and declining is high. The resistance is one of the critical technical analysis tools which market participants look at in a rising market. The resistance often acts as a trigger to sell.

Here is the chart of Ambuja Cements Limited. The horizontal line coinciding at Rs.215 on the chart, marks the resistance level for Ambuja Cements.



For a moment let us imagine Ambuja cement at Rs.206 forming a bullish marubozu with a low of 202. We know this is a signal to initiate a long trade, and we also know that the stoploss for this trade is at 202. With the new-found knowledge on resistance, we now know that we can set 215 as a possible target for this trade!

THE REASONS ARE SIMPLE :-

1. The resistance of 215 implies there is a likelihood of excess supply.
2. Excess supply builds selling pressure.
3. Selling pressure tends to drag the prices lower.

Hence for reasons stated above, when a trader is long, he can look at resistance points to set targets and to set exit points for the trade.

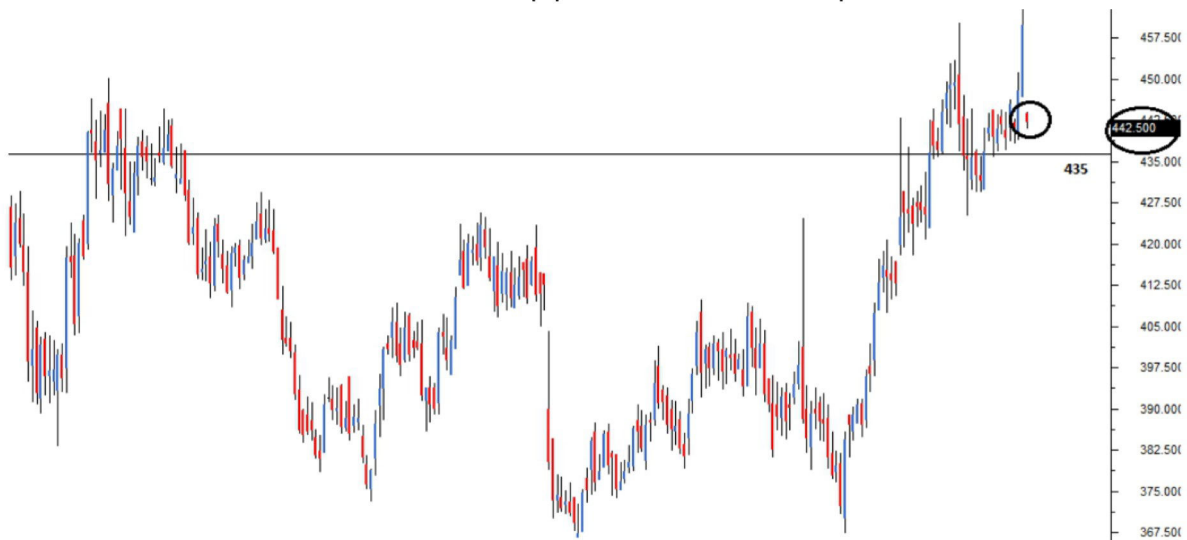

THE SUPPORT

As the name suggests, support is something that prevents the price from falling further. The support level is a price point on the chart where the trader expects maximum demand (in terms of buying) coming into the stock/index. Whenever the price falls to the support line, it is likely to bounce back. The support level is always below the current market price.

There is a maximum likelihood that the price could fall until the support, consolidate, absorb all the demand, and then start moving upwards. The support is one of the critical technical level market participants look for in a falling market. The support often acts as a trigger to buy.

Here is the chart of Cipla Limited. The horizontal line coinciding at 435 on the chart marks the support level for Cipla.



FEW THINGS THAT YOU NEED TO NOTICE ON THE CHART ABOVE:

1. The support level, indicated by the horizontal line is below the current market price.
2. While the support level is at 435, the current candle is at 442.5. The current candle and its corresponding price level are encircled for your reference

Like we did while understanding resistance, let us imagine a bearish pattern formation – perhaps a shooting star at 442 with a high of 446. the call is too short Cipla at 442, with 446 as the stop loss. Since we know 435 the immediate support, we can set the target at 435.

So what makes Rs.435 target worthy? The following reasons back the decision:

1. Support at 435 implies there is a maximum likelihood of excess demand to emerge.
2. Excess demand builds buying pressure.
3. Buying pressure tends to drag the price higher.

Hence for the reasons stated above, when a trader is short, he can look at support points to set targets and to set exit points for the trade.

CONCLUSION

We will learn to identify Support and Resistance in subsequent articles. The support and resistance lines are only indicative of a possible reversal of prices. They by no means should be taken for ascertain. Like anything else in technical analysis, one should weigh the possibility of an event occurring (based on patterns) in terms of probability.

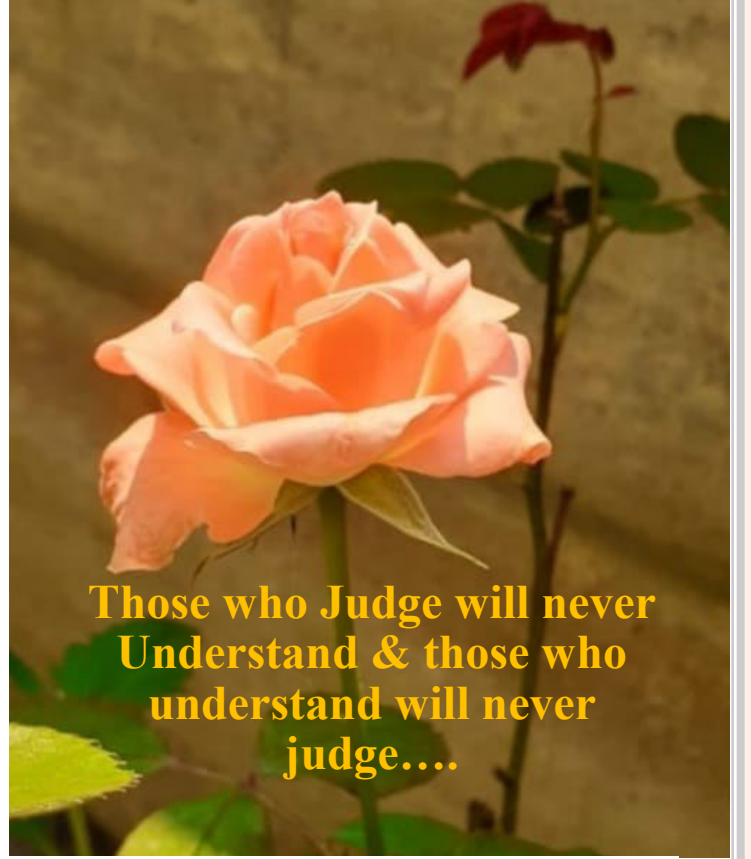

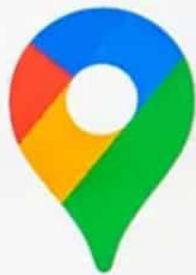

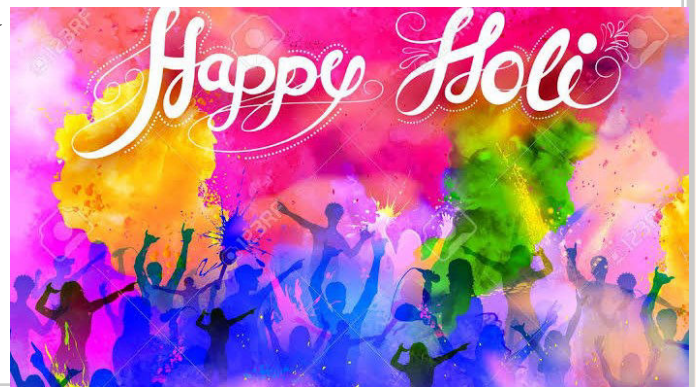


Holi 2022 Significance And History:
