Successful & Proud MITians as Academicians



Dr. Vaidehi Vijayakumar, renowned Academician and Researcher with 40 years of academic experience, did her BE in ECE at College of Engineering, Guindy, University of Madras, ME in Applied Electronics at Madras Institute of Technology (MIT). She did her Ph.D in “Scheduling Algorithms for Multiprocessor systems and their applications to the Kalman-Tracking algorithms” at MIT, Anna University, Chennai. She underwent advanced training in Multimedia Networking at Ryerson University,

Toronto, Canada.

She started her career at Indian Institute of Science, Bangalore in 1980 as Scientific Assistant in School of Automation and Computer Science and joined Madras Institute of Technology in 1982 as Lecturer in Electronics Department.

Academic contribution

During her service period in MIT from 1982 to 2016, she played a major role in setting up Computer Centre at MIT, Department of Information Technology and Department of Computer Technology at MIT.

She had taken up several administrative responsibilities such as Head-Computer Centre, HoD-Information Technology, HoD-Electronics Engineering, HoD-Computer Technology, Chairman -Faculty of Information and Communication, Anna University, and Director-AU-KBC Research Centre.

She was a Dual Degree co-ordinator and taken steps to offer IT course to non-IT branch students. As a Chairman of Information and Communication Technology, she formulated curriculum and syllabus to enhance the placement opportunities for students. As a placement officer of MIT, she helped the students in getting placements.

She has organized several Conferences, workshops, seminars and Faculty Development Programs in association with Industry for the benefit of students and faculty. She has executed several funded projects, worth 5 crores.

She has guided 27 PhD, 9 MS scholars. She has published 109 reputed journal papers and 273 conference papers and 4 book chapters. Her h index is 25, i10 index is 85, and citation is 2634. After her superannuation from MIT, she had served as Senior Professor and Dean, at School of Computing Science and Engineering, VIT, Chennai. She is the Senior Member of IEEE, Fellow of IETE, Life member of ISTE and CSI. Currently she is the Vice Chancellor of Mother Teresa Women’s University (MTWU), Kodaikanal.





My Entrepreneurial Journey

Off to a Bad Start in 1972:

My entrepreneurial journey started while I was in the final year (21st batch) at MIT. A few of us from the final year Electronics suddenly decided that we would start an industry soon after graduation and would not work for any one!! None of us had any business family background and I certainly did not have any money. But we went ahead and would keep our Board meetings at a sandy part behind the Aero department.



We formed a company with a name and style of **MITRONICS (MIT Electronics)**. One of our seniors, Venu (God Bless him) from the 20th Batch had a house near my home in Chetput and he offered the use of his garage for our first factory. Then I made a trip to ECIL Hyderabad to meet Mr. Waralu who was the GM of the Nuclear Instruments Div. When I explained to him our plan, to my utter surprise, he told his team to outsource the manufacturing of GM Counter to us and he told them to offer all the help.

Similarly in Delhi Mr. Raman from Intron offered to outsource some wound components manufacturing to us. I returned with a great sense of achievement to find that one by one my fellow Board members started dropping out and within a short time I was the only one left. I then decided the futility of ploughing a lone furrow and decided to wake up from the Start up dream.

My learning from this Start up experience:

1. If you are not from a business family, plan your start up after you learn the ropes at some one else's expense.
2. Ensure that you have some initial money available.
3. You should be a dreamer and willing to back your dreams with extreme hard work with a do or die attitude. Since I had none of these, I gave up and joined a company. But the highlight of our efforts done at that time was that MIT Alumni will help each other without any reservations. This is a great motivator and the strength of being part of that family.

Genesis of MEL Systems:

After working in New Delhi and in Mumbai, I came back to Chennai in 1981 to start Electronics Diversification Projects for the Murugappa Group. While in Delhi, I completed a Marketing Management Course from the Faculty of Management Studies, Delhi U and a Full time Management Course from the IIFT School of International Management.

While in Mumbai, I did a three-month Management Course in Geneva at the International Trade Centre. These added depth to my understanding of Management of business. While in the Group, we formed a company called the Murugappa Electronics Ltd. We developed businesses in the areas of Soft Ferrites, magnetic Tapes, Test and Measuring Instruments etc.

Those days strangely, the large groups were restricted from entering many areas of electronics. Hence the Group decided to exit electronics business in 1995. I had a choice of moving on to other companies or move to the other parts of the Murugappa Group. At that time, I and Mr. Srinivasan who was my colleague and handling the T&M and the Agency business rediscovered our passion for entrepreneurship and decided to take the plunge. The Murugappa Group was very supportive. While they sold off three division in electronics, they offered the fourth one handling the T&M, Agency and the Automation and Control activities as a management buy out to the two of us. This is how MEL Systems was born in the year 1995. The Group helped us to structure the business as well as supported us with part of the initial equity as well. Eventually we bought over their stakes and we are now completely independent.

Activities and the Growth over the last 25 years:

When we became independent, we took over the assets of the division. We had a small turnover and around 30 employees. The Agency division gave us the required income to develop the other businesses like the Automation and the ATE business. In automation, we were working with the Murugappa Group companies to help them automate some of their processes. Based on the experience, we started to work with the other industries. We then had an opportunity to get the technology from a Singapore based company to build In circuit testers and that was a good business for a while till the technology changed. During that time we sold around more than 600 of these testers and many of them overseas including 40 of them to Intel worldwide. Our major customers in India were from Defence and this gave us a good entry into that market.

Defence and Aerospace Markets:

We work with them on Testing and Product Development. There are a large number of our ATEs working with the Forces as well as with the Defence PSUs. Some interesting projects we have done for Defence are:

1. Ruggedisation of Communication equipment for the Navy,
2. Modernisation of the Submarine simulator for the Navy,
3. Simulator cockpits for the LCA, MIG 21 Bis, etc,
3. Simulator for the aircraft refuelling,
4. Data Distribution Unit for the new Aircraft Carrier being built by the Navy and so on. We also work with ISRO on ATEs, simulators etc.

Automation and Control:

We are system Integrators in the areas of Weighing and Batching, Industry 4.0 including MES, Traceability, Robotics, etc. We have done many turnkey projects in Weighing and Batching including some projects overseas in the US, UAE and Poland. We also build some SPMs when the customers demand them. Our growth plans in this division revolve around Digital Factories and Robotics. We work closely with Epson, Yaskawa and Doosan Robotics (For Cobots). We can configure the systems as well as take care of the SW development.

Electronics Systems:



We develop ATEs in this group for varied applications. Most of the cell phone chargers made in India are tested using our ATEs. We also work with many companies in developing custom automatic Testers for their products. These include many MNCs. We are now closely working with the EV industry in the ATE area for the batteries, Chargers and other systems.



My Entrepreneurial Journey ...contd

The Agency Business:

We represent a large number of overseas companies and offer their products in India. These are all cutting edge tech products used in electronics manufacturing, Photonics, Optical fibre manufacturing, etc.

Team Melss:



We have around 140 employees. All are qualified in their respective domains. More than 70% are engineers from multi engineering skills in Electronics, Mechatronics, Mechanical, Software, Electrical etc. We outsource all the work which require blue collar personnel. We have a family environment and have a number of employees who have been with us for more than 10 years. We are highly decentralised and the employees are empowered and hence motivated.

Value Systems:

We inherited the high standards of value systems from the Murugappa Group including Integrity, Customer focus, long term view of the business etc. We maintain these at the cost of having to stay away from some of the businesses but we are committed to the system and we enjoy the same.

MITEA:

I am glad that Dr Vazhudhi has been able to get the MIT Alumni entrepreneurs together to form this family. I am quite happy to be a part of this effort and I wish all of you great success in all your endeavours. Connecting to Light -- Light channeling technique


